MEDICARE SEMINAR

Part 1: Learn about the new laws under Medicare this year. There are many changes that many do not know about. Some of these changes will affect your daily charting and additional paper work.

Learn about the "Welcome to Medicare Package". What it means to the patient and the office. What does Medicare cover when you become of Medicare age? Did you know that Medicare will now pay for a yearly physical? Learn about the incentive programs Medicare has to bring in revenue to the practice.

If you are not on electronic medical records, when do you have to start? Learn about the increased revenue the office can have by sending electronic prescriptions. If you use Quest Labs through your computer, did you know that you can send prescriptions through them?

Part 2: ICD-10 is it finally going to happen? Yes it is and will you be prepared? During this session we will hear how are charting needs to be more descriptive in the chief complaint. It will need to be more in depth.

After learning about the codes there will be a practice session with examples of what the chief complaint is and the final diagnosis. You will then learn how to code, with the new codes.
